#### **Information on the continuation of NBC sports operations in 2021**

The NBC Executive Board discussed on December 4th and 5th, 2020. The meeting took place as a hybrid event both in presence in Erfurt and online via Zoom. Until the publication of our resolutions, it was agreed that the members of the Presidium would calmly consider everything again and, if necessary, include further opinions. The resolutions directly affect the further course of the season and also affect the following 2021/22 season.

1. **The 2020/2021 season is completely canceled.** After the team cup and Champions League competitions, this also applies to the U23 Single World Cup and General Class competitions planned for the 2021 calendar year in Schönebeck (GER), but also to the competitions relocated to Tarnowo Podgorne (POL) in May 2021 (U14 World Cup, WM U18, WM Team and EM Ü60).

2. Since in some nations it is important for the **receipt of state subsidies** to take part in world championships in the sport in the calendar year, the Presidium looked for a possibility to offer this. For this, it was necessary to find a time and mode that has a long time lag to the still existing COVID 19 pandemic, but also ensures a normal start and course of a season 2021/22.

3. The Presidium proposes to the nations that the **Team World Cup 2021** should be held between August 24th and September 4th, 2021 under special conditions that will be agreed with the nations. These conditions are based on the extraordinary Corona situation and expressly only apply to this World Cup.

The game is played for men and women on separate existing facilities (nine pin bowling halls) with at least 6 lines each. The halls are a maximum of 20 km apart.

The competitions take place without viewer. (This also means that the women are not allowed into the bowling hall with men - the men are not allowed into the bowling halls from the women). There is a breaktime after every 2 match days.

4. No uniform position could be found about a **U18 World Cup**. A possible compromise can be that U14 / U18 - Single World Cups are added to the schedule at the World Cup locations or take place at a different location at the same time.

5. The nations are asked for their opinions on items 3 and 4. That is planned for January 2021.

6. The **final of the Champions League 2019/2020** (Final Four), which is still open, can be played on the weekend of May 22/23, 2021 under the conditions as in point 3. The qualified teams will be queried after a possible venue has been found. If it does not take place on the specified date, the Final Four tournament is canceled.

7. The **NBC conference** is scheduled for May 29, 2021. The applications to the 2020 conference will be handed over to the submitters for consideration of retention. There are elections to the NBC Presidium. The conference can confirm or correct the upcoming events (points 3 and 4) and the following calendar. As the location of the conference, it will be checked whether the hotel in Bratislava can be used again.

8. In the event that national leagues or championships are held until July 2021, the **change of club membership** of the athletes can be extended from 07/15/2021 to 07/31/2021 upon request.

9. The **international railway inspections** on The facilities in Ajka, Repcelak, Kazancbarcika and Tatabanya (all HUN) are not recognized by the NBC. A suspensive effect of the previous web acceptance is allowed.

10. On the basis of the DKB's application, an examination of the previous "disclaimer" was commissioned by a Viennese sports attorney's office. As a result, the "disclaimer" is replaced by "**Conditions of Participation**" in connection with the new "Regulations on data protection". Both documents will be published on the NBC homepage.
